
Evaluation of individual Fragrance ingredients is made according to the safety standards contained in the relevant section of the IFRA Code of Practice.

Annex: Definition of IFRA Classes

Lip products of all types (solid and liquid lipsticks, balms, clear or coloured etc.); Children's toys	IFRA Class 1 Limit
Deodorant and antiperspirant products of all types including any product with intended or reasonably foreseeable use on the axillae or labelled as such (spray, stick, roll-on, under-arm, deo-cologne etc.); Body sprays	IFRA Class 2 Limit
Eye products of all types (eye shadow, mascara, eyeliner, eye make-up, eye masks, eye pillows, etc.) including eye care and moisturizer; Facial make up and foundation; Make-up remover for face and eyes; Nose pore strips; Wipes or refreshing tissues for face, neck, hands or body; Body and face paint (for children and adults); Facial masks for face and around the eyes	IFRA Class 3 Limit
Hydroalcoholic and non-hydroalcoholic fine fragrance of all types (Eau de toilette, parfum, cologne, solid perfume, fragrancing cream, aftershaves of all types, etc.); Fragranced bracelets; Ingredients of perfume kits and fragrance mixtures for cosmetic kits; Scent pads, foil packs; Scent strips for hydroalcoholic products	IFRA Class 4 Limit
Body creams, oils, lotions of all types; Foot care products (creams and powders); Insect repellent (intended to be applied to the skin); All powders and talc (excluding baby powders and talc)	IFRA Class 5A Limit

Hand wash laundry detergent (including concentrates); Laundry pretreatment of all types (e.g. paste, sprays, sticks); Hand dishwashing detergent (including concentrates); Hard surface cleaners of all types (bathroom and kitchen cleansers, furniture polish, etc.); Machine laundry detergents with skin contact (e.g. liquids, powders) including concentrates; Dry cleaning kits; Toilet seat wipes; Fabric softeners of all types including fabric softener sheets; Household cleaning products, other types including IFRA Class 10A Limit fabric cleaners, soft surface cleaners, carpet cleaners, furniture polishes sprays and wipes, leather cleaning wipes, stain removers, fabric enhancing sprays, treatment products for textiles (e.g. starch sprays, fabric treated with fragrances after wash, deodorizers for textiles or fabrics); Floor wax; Fragranced oil for lamp ring, reed diffusers, pot-pourri, liquid refills for air fresheners (non-cartridge systems), etc.; Ironing water (Odorized distilled water) Animal sprays – sprays applied to animals of all types; Air freshener sprays, IFRA Class 10B Limit manual, including aerosol and pump; Aerosol/spray insecticides Feminine hygiene conventional pads, liners, interlabial pads; Diapers (baby IFRA Class 11A Limit and adult); Adult incontinence pant, pad; Toilet paper (dry) Tights with moisturizers; Scented socks, gloves; Facial tissues (dry tissues); Napkins; Paper towels; Wheat bags; Facial masks IFRA Class 11B Limit (paper/protective) e.g. surgical masks not used as medical device; Fertilizers, solid (pellet or powder) Candles of all types (including encased); Laundry detergents for machine wash with minimal skin contact (e.g. liquid tabs, pods); Automated air fresheners and fragrancing of all types (concentrated aerosol with metered doses (range 0.05-0.5mL/spray), plug-ins, closed systems, solid substrate, membrane delivery, electrical, powders, fragrancing sachets, incense, liquid refills (cartridge), air freshening crystals); Air delivery systems; Cat litter; Cell phone cases; Deodorizers/maskers not intended for skin contact IFRA Class 12 Limit (e.g. fabric drying machine deodorizers, carpet powders); Fuels; Insecticides (e.g. mosquito coil, paper, electrical, for clothing) excluding aerosols/sprays; Joss sticks or incense sticks; Dishwash detergent and deodorizers - for machine wash; Olfactive board games; Paints; Plastic articles (excluding toys); Scratch and sniff; Scent pack; Scent delivery system (using dry air technology); Shoe polishes; Rim blocks (toilet)
